## About the EOMS Standard

EOMS is the Management Systems for Educational Organizations- ISO 21001:2018. It is the first ever International Management System Standard published by ISO specifically for the education sector. This stand-alone Management System standard focuses on the specific interaction between an educational organization, the learner, parents, educators and other relevant interested parties.

This is the only educational standard which is in line with the mission of UN Sustainability Development Goal- (SDG 4 - Quality Education- Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all).

The standard has been accepted by around 163 member countries of the International Organization for Standardization (ISO, Geneva).

The EOMS Certificate awarded to the schools by COAE is Accredited/ Recognized by the National Board of Education & Training (NABET), Quality Council of India under Ministry of Commerce and it provides an International recognition too.

A school that gets certified establishes the credibility of its management system including the strengthening of its scholastic, co-scholastic and administrative processes (including Safety, Security, HR, IT, Transportation, Learning environment etc.).

The Certificate once awarded to a school is valid for three years subject to satisfactory conduct of annual surveillances.

Since this standard has been developed with a holistic approach for the education sector, it can be easily mapped with any other National standard/ guidelines.

An effective implementation of the requirements of this standard can help any school establish and strengthen its overall management system in each area of the school.
